CONTEST FOR THE CREATION OF THE LOGO OF THE V WORLD ULTREYA OF CURSILLOS MOVEMENT

REGULATION

Brief framing

The Executive Committee of the World Organism of the Cursos Movement (OMCC), based in Portugal, took the initiative to hold the V World Ultreya of the Cursos Movement, which will take place in Fatima, Portugal, on May 6, 2017, date when simultaneously we will celebrate the 100 years of Eduardo Bonnin Aguiló birthday (May 4, 1917), and 100 years of the first apparitions of our Lady to the three shepherds of Fatima (13 May, 1917).

To give substance to the image of V World Ultreya, we decided to launch a challenge to cursillistas from all over the world, and appeal to the ideas and creativity of whole the *cursillista* family, with the launch of a contest of ideas for the creation of the V World Ultreya logo.

1. Objective

1.1.

This contest aims at the creation of the logo of the V World Ultreya of the Cursos Movement, under the motto: **"it's time for the Cursos"**, and with three basic concepts: **Christ, Person and Friendship**.

1.2. This contest aims to promote and urge the participation of *cursillistas* from all over the world, stimulate and reward imagination and creative ability of whole the *cursillista* family.

1.3. This tender aims to select the logo of the V World Ultreya of the Cursos Movement, which will be used, among others, in the following formats and of disclosure:

- Graphic image and documents of the V World Ultreya of the Cursos Movement;
- Posters, leaflets, brochures and other promotional material of the V World Ultreya of the Cursos Movement;
- Any other elements, paper-based, digital media or multimedia, in particular, elements or publicity materials (Internet) of the V World Ultreya.

2. Competitors

2.1. The competition is intended exclusively to those who have been through a Curso, and the proposals should be presented in individual name. Participants may submit more than one proposal, and, in this case, presenting them as stand-alone applications.

2.2. Participants are responsible for the originality of the works presented, ensure the authorship and disclaim all liability for third party claims with regard to copyright and related rights.

2.3. By participating in the contest, competitors declare to know and accept the terms of this regulation.

3. Features of the proposals

3.1. The works presented must expose features that reflect and identify a universal image of the V World Ultreya and must be submitted in digital form (PDF or JPEG file, and in editable files, being sent by mail or by other electronic means) joining the following elements:

- The number of colors of the logo is limited to 4 (CMYK);
- Logo graphics in two different sizes, a large and a small, and in last that case submit a minimum of 5 cm;
- Description and justification of the option presented, consisting of a text which describes briefly the concept developed at work.

4. Presentation and identification of works

- 4.1. The works presented to the contest should not contain personal particulars or any element that identifying it with an international group or country.
- 4.2. The work should allow full use on different supports, without loss of definition, even when reduced or enlarged.
- 4.3. The works must be sent, identified and accompanied by the corresponding enrolment form and Declaration, to the Executive Committee of the World Organism of the Cursos Movement, for the emails:

omcc.charism@gmail.com and omcc.portugal@gmail.com.

5. Deadlines for submission of tenders

- 5.1. The deadline for submission of proposals ends on the April 31th (Thursday) 2016.

6. Jury

- 6.1. The jury is composed of the members of the Executive Committee of the World Organism of the Cursos Movement.
- 6.2. To the Jury compete the opening of the tenders received, the verification of compliance with the requirements of the proposals, the evaluation of contest works accepted.
- 6.3. The decision of the jury is sovereign, excluding the possibility of appeal.
- 6.4. The Jury reserves the right to not assign any prize if considers that the quality of the work not justified it, or if there is not enough works presents.
- 6.5. To the Jury compete to not accept proposals that are not in compliance with the contest rules.

7. Criteria for assessment of the work

- 7.1. The methodology for the evaluation of work will be determined by the Jury, and must be taken into consideration the following criteria:
 - a) Creativity and Innovation;
 - b) Artistic quality;
 - c) Coherence and cohesion;
 - d) Suitability for purpose of the contest;
 - e) Allusion to the elements referred.

8. Prizes

- 8.1. This contest will award a prize to the winner logo.
- 8.2. The prize will be a plaque referring to the winner of the contest, and the costs of accommodation in Fátima (for two persons / two days) for participation in the V Ultreya World

9. Property rights

- 9.1. By participating in the contest, competitors say that they give in to the Executive Committee of the OMCC, the property rights of submissions.
- 9.2. The proposals sent to the contest will not be returned and the most relevant may be subject to exhibition at V World Ultreya.

10. Publication of results

- 10.1. The results of the contest will be published on the website of the OMCC, on a specified date.

Frances Ruppert honored with “Wolfgang Medal”

Regensburg, Germany

Frances Ruppert, having been active in the Cursillo movement for more than 50 years, was awarded the “Wolfgang Medal” by Bishop Dr. Rudolf Voderholzer on January 24th. This is the highest honor for lay people in the diocese of Regensburg.



Frances has worked in the leader team in numerous Cursillo weekends, in which many participants have found Jesus Christ as their friend. And she also played an important role in the worldwide development and growth of the Cursillo movement.

Frances experienced her first Cursillo in the USA, where she then helped to build up Cursillos for women. After her relocation to Germany she joined the Cursillo team in her home diocese of Regensburg and was instrumental in the introduction and growth of Cursillos in many dioceses in Germany and in the Czech Republic.

Not only was she member of the German National Coordination Team (CAD); on an international level Frances served as President of the European Cursillo Movement (GECC) and as President of the Worldwide Cursillo Movement (OMCC) from 1998 till 2002. During this time the first draft of the statutes has been submitted.

Her dedication for Christianity reaches far beyond the Cursillo movement. Just one example: Frances was also active in the formation of “*Together for Europe*”, an ecumenical initiative of Christian communities in different churches with the goal to get to know each other and to reconcile differences with mutual respect and support.

Not to forget the activities in her direct neighborhood: the service in her home parish in Landshut and for the Ultreyas of the local Cursillo community - and last but not least for her large family.

Everyone who may get to know Frances is deeply impressed by her dedication, her passion and her charismatic Christian personality. She has really deserved this honor and we all share her joy.
